## Share Purchase Plan – Closes 30 April 2020

NEXTDC Limited (ASX: NXT) (“**NEXTDC**” or “the **Company**”) advises that as at 27 April 2020, applications for \$86 million worth of new fully paid ordinary shares (“**New Shares**”) have been received from shareholders eligible to participate in the Share Purchase Plan (“**SPP**”).

Details of the SPP were announced to the ASX on 14 April 2020 and the SPP Offer Booklet along with personalised Application Forms were dispatched to eligible shareholders on the same day.

The SPP offer will close at 5.00pm (AEST) on Thursday, 30 April 2020 (“**SPP Closing Date**”).

Under the SPP, eligible shareholders have the opportunity to acquire up to \$30,000 worth of New Shares without brokerage or transaction costs. There is no cap or scale back on the SPP.

The SPP issue price will be the lower of the Placement Price of \$7.80 per share or the volume weighted average price of fully paid ordinary shares in NEXTDC traded on the ASX over the five trading days up to and including the SPP Closing Date. Accordingly, the maximum price that eligible shareholders will pay is the Placement Price of \$7.80 per share. The NEXTDC share price was \$8.38 per share at the close of trade on 27 April 2020, which represents a premium of approximately 7% to the Placement Price.
