POWER

Is the entire facility protected by UPS including all mechanical plant equipment allowing continuous cooling?		
Does the site operate with a minimum of N+1 electrical configuration with a concurrent maintainability?		
Can the provider support power density of greater than 20KW per rack if required?		
Is there a minimum of 24 hours backup fuel supply held on site?		
Are the Generators continuous rated for 24 x 7 x 365 operation if required?

FIRE PROTECTION		
Does the facility have MASDS smoke detection within Data Halls (e.g. VESDA)?		
Does the facility have outside air quality detection and automated bushfire shutdown?		
Are all zones 2hr fire rated compartmentalized throughout the facility reducing the risk of catastrophic failure?		
Does the facility have thermal, smoke, and flame detection providing early fire detection?

NETWORK AND CONNECTIVITY		
Is the data centre carrier neutral?		
Is there direct and secure access to cloud platforms, digital services, and carrier networks?		
Are there at least two internal secure carrier meet-me-rooms accessible by completely diverse fibre paths?		
Is direct access and connectivity available to major cloud providers?		
Is the network diverse and redundant with diverse fibre routes into the data centre?

SECURITY		
Is the facility equipped with an anti-scale perimeter security system?		
Is the facility staffed 24/7?		
Are there customised private security cage solutions available?		
Are there security portals (mantraps) to control access to the secure areas of the facility?		
Is the facility equipped with motion-sensitive, high definition CCTV cameras with coverage of all access points and throughout the facility stored for a minimum of 90 days?		
Does site orientation require government-issued photo ID?		
Are there individual and remote access controls to customer cabinets and cages with rack access controlled electronically with an audit trail available?		
Are there secure, undercover loading docks available?



Is there a TV and/or pinball machines provided in the customer breakout area?		
Are disaster recovery suites/space options available?		
Are end of trip facilities available, including showers and change rooms?
